The aim of the project is to increase professional competencies of 40 people from the target group of the project – addiction specialists and/or local government employees from Georgia – in terms of planning, design and implementation of local preventive programmes.

Study visits in Poland

First Study visit – October . About 20 participants

Participation in an international conference in Warsaw organized by the National Bureau for Drug Prevention (2 days) - monitoring of a drug prevention programme at the local level; quality in prevention; new psychoactive substances

Participation in the seminar only for the Georgian group (1 day) - the problem of preventive local activities.

Second Study visit – November. About 20 participants

Participation in an international conference in Warsaw organized by the Mazovian Center for Social Policy (2 days) - presentation of the EMCDDA report; counteracting new psychoactive substances; environmental prevention; harm reduction – programmes, implementation, financing

Participation in the seminar only for the Georgian group (1 day) - the problem of preventive local activities.
